INTRODUCTION

This report to the Council covers the period from 12 March 2004 up to, and including, the Trustees' meeting on 14 March 2005. It lists for the period new research grants approved by the Trustees and developments in the main schemes of the Trust. The audited Trust accounts for the year ended 31 January 2005 are given as Appendix 1.

A full account of the Trust's activities in earlier years may be found in Annual Reports volumes I to XIV. A summary of grants made over the last 10 years (July 1994 to March 2005) is given in this report as Appendix 2. Grants made before July 1994 appear in volume XIV.

The Trustees express their thanks to Baroness O'Neill PBA, who completed her period of service as a Trustee on 30 September 2004. Professor Q R D Skinner, was appointed as a Trustee from October 2004.

The Trust maintains a website (www.newtontrust.cam.ac.uk) that gives up-to-date details of the Trust schemes. Those web pages that are concerned with the Bursary scheme (see page 13) are accessible to prospective applicants for undergraduate places from outside Cambridge. The remaining pages, including guidelines to applicants for grants, are accessible only from @cam addresses.

AIMS AND OBJECTIVES OF THE TRUST

To promote education, learning and research in the University of Cambridge.

FINANCIAL SUMMARY

General Fund

Trinity College has agreed to make donations to the Trust for the next five years of £2 million per annum. These donations are credited to the Trust's General Fund. Grants from the General Fund are made to specific research projects and also to recurrent Trust schemes. A summary of the grants made from the General Fund from 1988 up to 14 March 2005 is shown in Table 1 and in graphical form in Figure 1. A breakdown of grants by Department made in the last ten years (1994-2005) is shown in the Yellow Table in Appendix 2. A comprehensive list of earlier grants is shown in the Trust's Annual Report Volume XIV.

There was a further recovery in the value of the Trust's investments during 2004-05 as a result of improved market conditions.

The Trust's expenditure has exceeded its income (conventionally defined) in each of the past three years.

The projections of future expenditure in Table 1 are speculative both as to amount and to timing. They include all the grants that the Trustees have approved, though experience suggests that some 20% of these grants will not, in the event, be taken up, either because circumstances change or else because the matching conditions have not been met.

Two projections of future expenditure are shown in Fig.1. Solid lines show the commitment projections of Table 1. Dotted lines show an extrapolation of present expenditure (averaged over the past 4 years including 4% inflation) to make allowance for possible future decisions of Trustees.

Administration Costs

Expenditure on Administration is much the same as in previous years and represents less than 3% of the Trust's turnover. A breakdown of Administration costs in 2004-05 is shown below.



RESEARCH AND TEACHING GRANTS APPROVED 2004-2005

POLICY

The policy of the Trust in relation to Research and Teaching Grants is summarised in its Guidelines to Applicants. The key features of those Guidelines during 2004/2005 were as follows:

- The Trustees realise that the funds at their disposal could soon be wholly absorbed in a few big projects. They believe they can best assist the University by focusing their help selectively on projects of various sizes which otherwise might not get started or be significantly delayed, particularly those where a grant from the Trustees can open up opportunities for additional funds from outside Cambridge. The Trust is able to move quite quickly and so help in enabling opportunities to be seized which otherwise might permanently be lost. In all cases the Trustees need to be satisfied that projects are of a high standard. They aim to assist with the funds at their disposal a wide range of projects, covering many departments and faculties across the humanities and sciences.
- Since one of the purposes of the Trust is to attract resources from outside, grants from the Trust are normally conditional upon raising from sources outside Cambridge at least twice the amount of the grant. The Trustees have agreed to vary or even set aside this condition for projects that they consider of particular importance where the prospects of obtaining such external funding are remote.
- When applications are made to Research Councils in a routine way, the Trust will expect applicants to apply to the Councils for the full amount of the funds that they require. If a particular application is not wholly successful, the Trustees may be willing to consider an application for a top-up grant from the Newton Trust for a new initiative or project they regard as particularly important; and may allow the partial grant from the Research Council to be regarded as matching funds; but they do not guarantee to do so.
- The Trustees are persuaded that their most effective contribution is to help attract talented persons to Cambridge and to maintain the University's reputation as a centre of excellence in research. Thus the aim of the Additional Appointments Scheme (by which grants are made of up to £16,000 per annum for no more than 5 years, subject to matching amounts being raised from outside sources) is to provide limited-tenure research posts, perhaps involving a small amount of teaching, for younger academics.
- The Trust does not normally contribute towards the costs of pre-doctoral students because PhD studentships are available from Research Councils, from the Cambridge Commonwealth, European, Overseas, and Gates Trusts, and from the Domestic Research Studentships competition organised by the Board of Graduate Studies.
- The Trustees do not in their own right seek funds from outside (the only exception being the scheme of Newton Bursaries for undergraduates). It is therefore the responsibility of recipients of grants to raise the additional monies which are a condition of their grants from the Trust.

• The Trustees do not give priority to grants for equipment and in particular do not normally support requests for replacement of standard items. However, they have made modest provision for equipment grants and will give priority to requests for new equipment for teaching or new equipment which has multiple use. Such grants will normally be for no more than one-third of the total cost. The Trustees do not normally entertain requests for "bricks and mortar" projects.

APPLICATIONS

In 2004-05 the Trust received a total of 54 new applications for support; much the same as the record level in 2003-04. The total cost of supporting these applications in full would have been $\pounds 2.8m$. In the event, 39 applications were supported at a total cost of $\pounds 1.3m$ (many grants being made at a lower level than had been requested), and 15 applications were rejected.

GRANTS AWARDED

The following grants (totalling £1.3million) were approved by the Trustees during the report period. They are listed alphabetically by Department. The amounts of individual grants may be found in Appendix 2 (Yellow Table). If the matching requirement associated with each grant is achieved, the total matching sum associated with these grants will be £1.2 million. In some instances this matching sum would no doubt have come to Cambridge anyway; in others it has been elicited by the Newton Trust grant.

Anatomy: A grant in the form of underwriting towards the salary of Dr Liz Muir for one year to work as a senior researcher with Dr Roger Keynes on a project to investigate nerve regeneration entitled, 'Development of a novel strategy for repair of spinal cord injury', together with a grant for consumables.

Anatomy: A grant over two years towards the cost of consumables for use by Dr Clare Baker under the supervision of Professor William Harris on a project looking into human birth defects entitled, 'The role of *Pax3* in the Trigeminal Ganglion'.

Anatomy: A grant for one year towards the salary of Dr Chris Wilkinson to work as a postdoctoral researcher with Professor William Harris on a project entitled, 'The role of the centrosome in vertebrate development'.

Applied Mathematics and Theoretical Physics: A grant over three years towards the salary of a postdoctoral researcher to work with Dr Gordon Ogilvie and Professor Michael Proctor on a project entitled, 'Instabilities, turbulence and angular momentum transport in astrophysical discs', together with a grant towards the cost of computer equipment.

Biochemistry: A grant towards the purchase of a fluorimetric detection mode upgrade for a microtitreplate reader with UV/VIS to support the work of Dr Florian Hollfelder in advancing the study of enzyme catalysis.

Biochemistry: A grant for four months towards the salary of Dr Susana Vílchez as a postdoctoral researcher to work with Professor David Ellar on a project entitled, 'Application of Phage Display Technology to Create Novel Biopesticides' as bridging funding pending the outcome of an application to the Leverhulme Trust.

Biochemistry: A grant towards the purchase of a confocal microscope with ancillaries for use by Dr Richard Farndale and others for live-cell imaging in physiology and pathology.

Biotechnology: A grant for one year towards the salary of Dr Simon Scofield to work as a Research Associate with Dr James Murray on a project entitled, 'New roles for master regulators of plant stem cells'.

Centre for Research in the Arts, Social Sciences and Humanities (CRASSH): A grant over three years towards the salary of an Editorial Research Assistant to work with Dr Richard Serjeantson on a project to prepare Volume III of *The Complete Works of Francis Bacon (1561-1626)* to be published by Oxford University Press in 2009.

Chemistry: A grant for one year towards the salary of Dr Elena Bichoutskaia to work as a post-doctoral researcher under the supervision of Dr Nicholas Pyper on a project entitled, 'Fundamental quantum mechanical modelling of encapsulated nanocrystalline materials'.

Chemistry: A grant for one year towards the salary of Dr Stephen McLaughlin to work as a Research Associate on a project entitled, 'Understanding how the cell assembles complex structures: the role of molecular chaperones' under the supervision of Dr Sophie Jackson.

Chemistry: A grant over three years towards the salary of Dr Sergei Simdyankin to work as a Research Associate with Professor Stephen Elliot on a project entitled, 'Understanding photosensitivity in amorphous materials by means of computer simulation'.

Divinity (Centre for Advanced Religious and Theological Studies): A grant towards the salary of Dr Thomas Freeman as a Visiting Fellow to work with Professor Eamon Duffy on the preparation for publication of a corpus of manuscripts of the *Letters of the Marian Martyrs* held at Emmanuel College, together with a grant towards editorial costs.

Earth Sciences: A grant over two years towards the salary of Dr Stuart Hayward to work as a Research Fellow under the direction of Professor J F Scott on a project entitled, 'Quantum paraelectric solid solutions'.

Engineering: A grant over three years towards the salary of Mr Mohammed Hussein to work as a Research Associate with Dr Hugh Hunt on a project entitled, 'Control of vibration from railways'.

Engineering: A grant for three years towards the salary and travel costs of Dr Yongjiang Shi to work as a Senior Research Associate under the supervision of Professor M J Gregory on a project entitled, 'Making it in China - An investigation into the development of Chinese industrial capability and the implications for global manufacturing industries'. The project is to be undertaken in collaboration with Chinese universities.

Fitzwilliam Museum: A grant towards the cost of specialist analytical services and equipment for use on a project to investigate, examine and analyse the Ancient Egyptian collections of the Fitzwilliam Museum. The project is to be undertaken by Ms Julie Dawson, Senior Assistant Keeper (Conservation), under the direction of Mr Duncan Robinson.

Genetics: A grant for one year towards the salary of a post-doctoral scientist to work with Dr David Summers on a project entitled, 'Direct expression of foreign genes in bacteria', which seeks to develop novel technology for use in genome sequence analysis.

Geography: A grant for one year towards the salary of a post-doctoral researcher to work with Dr W Adams, Dr T Bayliss-Smith, Dr B Vira and Dr E Watson on a project entitled, 'Changing paradigms in natural resource management', which will investigate the comparative experience of environment and development debates in Africa, South Asia and Melanesia.

Haematology: A grant for one year towards the salary of Dr Ty Adams to work as a postdoctoral researcher under the direction of Dr James Huntington on a project entitled, 'Molecular recognition determining the pro- and anti-coagulant activities of thrombin'.

History of Art: A grant over two years towards the salary of Dr Linda Goddard as a Research Fellow to work on a project entitled, 'Using the Pen to Promote the Brush: Artists' Writings in *fin de siècle* France' which investigates in particular the writings of Paul Gauguin.

Isaac Newton Institute for Mathematical Sciences: A grant over two years towards the Institute's infrastructure costs. (Applicant: Professor Sir John Kingman)

Oriental Studies: A grant in the form of underwriting towards the costs of a meeting of contributors to a supplementary volume to *The Cambridge History of China, Volume I: The Ch'in and Han Empires.* (Applicant: Dr Michael Loewe)

Pathology: A grant for one year towards the salary of a Research Assistant to work for one year on a project entitled, 'Recognition of cellular distress by Natural Killer cells' under the supervision of Professor John Trowsdale.

Philosophy: A grant over ten months towards the salary of Dr Greg Scherkoske to work with Professor Simon Blackburn as a post-doctoral researcher on a project entitled, 'Public Trust and Professional Judgement'.

Physiology: A grant over two years towards the costs of consumables for use by Dr Alison Forhead on a project entitled, 'Developmental control of thyroid hormone bioavailability *in utero*' under the direction of Professor Roger Thomas.

Psychiatry: A grant for one year towards the salary of Dr George Ploubidis as a post-doctoral Research Associate to work under the direction of Professor Felicia Huppert on a project entitled, 'Human flourishing: a life-course approach', together with a grant towards IT and software.

Scott Polar Research Institute: A grant over two years towards the salary of Mr Robert Headland to work under the direction of Professor Julian Dowdeswell as an Archivist, with the purpose of providing continuity of scholarly advice and access to internationally-significant archival collections at the Institute.

Social Anthropology: A grant for six months towards the salary of Dr Monica Konrad to work as a Senior Research Associate under the supervision of Professor Dame Marilyn Strathern on a project entitled, 'An anthropological proposal for research in international ethics', which seeks to stress the relevance of contemporary social anthropology for the field of international ethics.

Social Anthropology: A grant for one year as a contribution to the salary of Mr Matei Candea to work as a temporary unestablished Teaching Associate in the Department of Social Anthropology in the academic year 2005-06. (Applicant: Professor Caroline Humphrey)

University Library: A grant over three years towards the salaries of one Senior Research Associate and four Research Associates to work under the direction of the Librarian, Mr Peter Fox, on a project to publish the complete scholarly edition of the correspondence of Charles Darwin.

Veterinary Medicine: A grant towards the salary of Professor Jonathan Heeney for six months to work with Professor Ian McConnell on a project entitled, 'The basis of immunity: the critical early events in lymph'.

Veterinary Medicine: A grant towards the costs of consumables for use by Dr Jordane Biarc under the direction of Dr Clare Bryant on a project entitled, 'The role of pathogen associated molecular pattern receptors in *streptococcus pneumoniae* infection'.

Wellcome Trust/CRUK Gurdon Institute: A grant over six months towards the salary of Dr Attila Toth to work as a post-doctoral researcher with Professor Azim Surani on a project entitled, 'Screening for genes involved in murine meiosis'.

Wellcome Trust/CRUK Gurdon Institute: A grant over six months towards the salary of Dr Stephen Sullivan to work as a post-doctoral researcher on a project entitled, 'To identify factors necessary for activation of the stem cell marker gene *Oct-4*' under the supervision of Professor Azim Surani.

Zoology: A grant towards the purchase of specialised laboratory equipment for use by Dr Walter Federle on a project entitled, 'Integrative study of insect surface attachment: adhesive mechanisms, dynamic performance and biomechanics of insect-plant interactions' under the supervision of Professor Malcolm Burrows.

Zoology: A grant towards the salary of Dr Sarah Bevan to work with Dr David Parker as a Research Associate on a project to examine the mechanisms underlying long-term spinal cord plasticity entitled, 'Long-term neural network plasticity: molecular mechanisms in a spinal cord locomotor network'.

Zoology: A grant over three years towards the salary of a post-doctoral researcher to work on a project entitled, 'Molecular physiology of the *C. elegans* Ip_3 receptor' under the supervision of Dr Howard Baylis.

Zoology: A grant for one year towards the salary of Dr L C Rookmaaker to work as an Archivist on a project to conserve, restore and make available for scholars the Hugh Strickland archive of ornithological and other papers bequeathed to the Museum of Zoology in 1900. (Applicant: Professor Michael Akam)

RECURRENT TRUST SCHEMES

THE CAMBRIDGE BURSARY SCHEME

Aims and objectives

The scheme of Newton Trust Bursaries for UK Undergraduates was set up in response to the freezing, and progressive phasing out of student grants, the introduction of student loans and later of tuition fees. The main purpose of the scheme is to help attract the best candidates to Cambridge and to widen the field from which they are drawn, through support for students from disadvantaged backgrounds and from families with modest financial resources.

Policy

The Trust has received three Special Donations from Trinity College towards the endowment of the Bursary scheme. In addition the scheme has been supported on a recurrent basis by several sponsors and by a donation of £1 million phased over seven years from Atlantic Philanthropies.

In the light of these donations, the Trustees agreed in 1999 to expand the bursary scheme substantially. A guarantee was offered that any student in receipt of full LEA fee remission (i.e. with a parental income of less than about £20,000) would receive a full bursary of £1,000, with a sliding scale for students who qualify on the basis of their parental income for a lower level of fee remission.

The cost of these awards is borne in part by Colleges, broadly in line with their endowment income per capita. Levels of contribution are shown in Table 3. St John's College has progressively taken over the cost of awards for its own students; in 2004-05 only fifth and higher year students at St John's were eligible to apply to the Trust.

The finances of the expanded bursary scheme are shown in Table 2, which includes the Newton Bursaries Endowment Fund, established to receive the Trinity College Special Donations earmarked for endowment of Bursaries.

A long-term evaluation of the bursary scheme, funded over ten years by Atlantic Philanthropies, is being carried out by the University's School of Education.

The scheme of bursaries is advertised on the Trust's web-site, in the University prospectus and in advertising sent to schools. This material includes a guarantee that any student who qualifies for full fee remission will also be awarded a full bursary.

The Trustees have agreed to maintain the present bursary scheme substantially unchanged up to 2006. Projections of costs after that date are speculative (see below).

Under the Higher Education Act passed in 2004, Universities are permitted to charge socalled top-up fees on condition that they have a bursary scheme in place which guarantees minimum bursaries to UK students from the poorest families. These arrangements are to be policed by a regulator, the Office for Fair Access (OFFA). Cambridge has decided to charge the maximum top-up fee permitted, and the University has asked the Trust to administer an expanded bursary scheme in fulfilment of the OFFA requirement. This will involve a substantial increase in bursary amounts, well in excess of the minimum required, and also a widening of the categories of student who will receive bursaries. The cost of the bursary scheme will increase substantially after 2006 as successive cohorts of students fall under the new fee arrangements, increasing to a steady state of about £7 million per annum by 2011. This cost will be met in part by a contribution from the University from the top-up fee, and in part, roughly at present levels, by the Newton Trust and the Colleges.

It is intended that fundraising for bursaries should be a major part of the University's 800th Anniversary Campaign. Several Colleges are already using student support as a major plank in their fundraising, some with notable success. With the agreement of all parties involved, an arrangement has been worked out whereby Colleges that are particularly successful in their fundraising for bursaries can meet a higher-than-normal share of the cost and they will then be reimbursed by the Trust. It is hoped that this procedure will incentivize College fundraising efforts.

The Newton Trust has taken a leading role in establishing these new arrangements and has accepted the invitation of the University Council and Colleges to continue to run the bursary scheme in this new and expanded form for at least three years after 2006.

Grants for Community-Related Projects

The Trust has continued to operate a scheme offering contributions to community-related undergraduate projects with preference being given to bursary-holders and those undertaking projects within the UK. Some 135 awards were made under this scheme in 2004-05 at a total cost of \pounds 24,210. Most of the grants to individuals were for sums less than \pounds 500, but within the total the Trust approved a grant of \pounds 2,000 to Student Community Action towards equipment and office costs.

Results of the 2004-05 Bursary allocation

All eligible applicants were awarded a bursary on a sliding scale up to £1,000 thereby meeting the Trust's guarantee. The number of awards made is given below (2003-04, 2002-03, 2001-02 and 2000-01 figures in parenthesis):

- a total of 1675 (1734) (1629) (1551) (1290) bursaries were awarded at a total cost of about £1,294,000 (£1,247,000) (£1,202,000) (£1,107,000) (£867,000);
- the cost to the Trust net of College contributions is about £1,052,000;

- of the total 1704 applications for bursaries (new and renewals), 47 were deemed ineligible to receive support;
- 359 of these awards remain to be settled upon receipt by the Trust of students' LEA assessments.

First year students (only) taking the Graduate Course in Medicine were invited to apply for a bursary. Eight of the 20 students applied; 6 bursaries were awarded.

The total number of bursaries awarded is more than twice as great as it was five years ago. About 20% of eligible UK students now receive bursaries.

Numbers and costs of awards by College are shown in Table 3.

For first-year students, the Higher Education Act has changed the definition of parental income so as to include step-parents. There was a 6% fall in numbers of applications from first-year students. The average value of each bursary awarded has increased from £720 to £770, in part because a larger sponsorship income offset (£1,000 rather than £200) was applied.

Collaborators

Atlantic Philanthropies, who hitherto preferred to remain anonymous, now publicly acknowledge the support that they offer to the bursaries scheme and advertise their grants on their own website and their name appears on the Trust's published accounts.

Armourers and Brasiers: Four Armourers and Brasiers awards were made.

Cambridge Society: The fifth Cambridge Society bursary has been awarded.

Clifford Chance: Clifford Chance continue to make a contribution to the bursary scheme at a level of £35,000 per annum.

Thermo Electron agreed to sponsor two bursaries of £6,000 over four years (£1,500 per year) to Natural Sciences students. Two Thermo Electron bursaries have been awarded.

For the remaining schemes (*Dharam Hinduja Newton Bursaries, Malaysian Commonwealth Studies*) the bursary recipients have been identified and the students notified. The usual contributions from the sponsors, $\pounds 15,000$ and $\pounds 20,000$ respectively, have been paid.

RESEARCH STUDENT FUNDING

The Trust supports Research Students at Cambridge in three ways: through the scheme of Awards for UK Research Students in the Arts, Humanities and Social Sciences described below; through the Board of Graduate Studies Scheme of Domestic Research Studentships (available to both UK and EU students) described on page 24; and through the scheme of Newton European Research Studentships (for EU students) operated by the Cambridge European Trust and described on page 25.

NEWTON AWARDS FOR UK RESEARCH STUDENTS IN THE ARTS, HUMANITIES AND SOCIAL SCIENCES

A new and experimental scheme of awards restricted to the Arts, Humanities and Social Sciences operated for the first time in 2002. Awards of £1,500 per year were offered for new PhD students from the UK holding either a 3-year Research Council maintenance grant or a similar 1-year Research Council grant with the intention of proceeding thereafter to the PhD degree in Cambridge. The scheme operated for the second time in 2003. A review by the Trust in 2004 decided that the scheme should be discontinued (details are contained in Annual Report Volume XIV pp.20-21).

No new awards were made under the scheme in 2004-05, but **29** awards are ongoing from those who started in 2002 and **33** awards are ongoing from those who started in 2003. The total cost of these awards in 2004-05 was **£90,500**.

COLLEGE TEACHING OFFICER (CTO) SCHEME

Aims and objectives

The aims of these schemes are to increase CTO involvement in Faculty teaching and the amount of University teaching available, allow Faculties to choose such extra teachers from CTO ranks as they wish, make it possible for the Tuition Funds of poorer Colleges to afford the consequent reduction in the amount of CTO teaching, and to achieve these aims through a scheme that is simple to operate. Tenure in these posts was initially limited to a maximum of ten years. In a recent review of the scheme the maximum tenure was reduced to 8 years so as to offer greater opportunity to CTOs appointed by Colleges for short periods to compete for a post.

The original scheme established in 1992 operates across faculties, though in practice most posts are in the Humanities. The broadly parallel scheme operated by the Faculty of Law with (half) sponsorship from Norton Rose is now closed, the five-year tranche of funding having come to an end.

Summary of awards 2004-2005

Thirty-three posts are currently filled. Two post-holders are currently on leave: Dr Bodenhorn and Dr Bennett. Dr Sarah Brown has been appointed for one calendar year from 1 January 2005 as a temporary replacement for Dr Bennett.

A list of present holders of awards is given in Table 4 below.

Costs

The cost of the CTO scheme for the academic year 2004-2005 was **£118,995**. The cost of the Norton Rose scheme in 2004-2005 was **£20,151**. The Norton Rose scheme is now closed.

Recent changes

Several new appointments, reappointments and resignations arose during the year:

Faculty of English

Dr Yota Batsaki (St John's) has been appointed of for five years from 1 October 2004.

<u>Dr Jan-Melissa Schramm</u> (Trinity Hall) has been appointed for 4.5 years from 1 January 2005 until 30 September 2009.

Faculty of Modern and Medieval Languages

Dr Erica Segre (Trinity) has been appointed for five years from 1 October 2004.

<u>Dr Sarah Cooper</u> (Trinity Hall) resigned her lectureship with effect from 30 September 2004. The resultant vacancy has been assigned to the <u>Faculty of English</u> by the School of Arts and Humanities.

Department of Physics

<u>Dr Julia Riley</u> (Girton) has been reappointed for a further and final two years from 1 October 2004.

Department of Social Anthropology

<u>Dr Barbara Bodenhorn</u> (Pembroke and Girton) is on leave for the two years 2004-2005 and 2005-2006. Her tenure has therefore been extended by two years to 30 September 2008. No temporary stand-in appointment has been requested by the Department.

Norton Rose Scheme (Faculty of Law)

<u>Mr Ben Parker</u> (St John's) resigned his Norton Rose lectureship from 31 December 2003 and was appointed to a University Lectureship from 1 January 2004.

<u>Dr Eleanor Spaventa</u> (New Hall) resigned her Norton Rose lectureship from 30 August 2004.

TIME-LIMITED TEACHING FELLOWSHIPS SCHEME

Aims and objectives

The aims and objectives of this scheme are to strengthen the undergraduate supervision system at the less well-endowed Colleges, thereby helping to produce a more even playing field between well-endowed and less well-endowed Colleges; and to help to integrate some of the holders of Newton Additional Appointments and similarly placed postdoctoral researchers into College life.

Policy

The Trustees agreed in 1999 to make up to 25 grants available to enable young postdoctoral researchers to be elected to teaching Fellowships at the less well-endowed Colleges shown below. Each appointment may be held for up to 5 years. The duties of each person appointed include giving 4 hours per week of undergraduate supervision. In return the Trust pays the College £4,000 per annum towards the overheads involved. In 2004 the Trustees agreed to increase the number of posts available under the scheme from 25 to 30 from 2005 onwards at an additional cost to the Trust of £20,000 per annum.

Appointments made

Eleven posts were taken up in the first round of appointments in 2000. The Trust has advertised further rounds of appointments annually since, and in the Easter Term 2004, vacancies were offered to eligible Colleges in competition. As a result, **8** new appointments were made and **3** appointments were extended up to the maximum 5-year tenure. Dr Caroline Blyth (St Edmund's) resigned her Fellowship from 31 August 2004 on taking up a University Lectureship in English.

GRANTS MADE TO OTHER BODIES

DOMESTIC RESEARCH STUDENTSHIPS

Aims and objectives

To award research scholarships to the best 'Home' (i.e. UK and EU) students who fail to gain support from public sources such as the Research Councils and the AHRB.

Policy

The Newton Trust agreed in 1997 to contribute £75,000 per annum for five years to a University-wide scheme, adding to other sources of funds to increase the number of awards available. The awards are made by the Board of Graduate Studies on the advice of Academic Division's Committee on Awards. The majority of awards are made to students in the Arts and Humanities. During 2003-03 the Trustees agreed to extend the period of support for a further five years at £85,000 per annum; and in 2004 agreed a further increase to **£90,000** per annum.

In addition, the Trust agreed in 2002 to provide underwriting of **£250,000** over a five-year period to enable firm offers of support to be made earlier by the Committee on Awards to strong candidates who might otherwise be tempted to go to other Universities but who were likely in the event to receive funding from public sources.

Grants awarded

In 2004 some **21** new awards were made. The Secretary of the Board of Graduate Studies reported that the availability of the Trust's underwriting had been useful in enabling early offers of awards to be made to students who might otherwise have moved elsewhere but who had, in the course of events, subsequently been awarded a studentship by AHRB. It has not yet proved necessary to call upon the Trust's underwriting.

NEWTON EUROPEAN RESEARCH BURSARIES

Aims and objectives

The aims and objectives of this scheme are to encourage able students from the European Union to do research at Cambridge and to help them take up their places. (EU students are eligible for support from public sources for their fees, but not at present for maintenance.)

Policy

The Trustees agreed in 1999 to make a donation to the Cambridge European Trust totalling $\pounds 600,000$ to provide a pilot scheme of Newton European (Research) Studentships of annual value up to $\pounds 2,000$ tenable for up to three years, to be awarded to PhD students from the EU by the Cambridge European Trust on the basis of departmental recommendations. A further $\pounds 400,000$ was awarded during 2002-03, and in 2004-05 the Trustees agreed to make a further and final grant of $\pounds 400,000$ over two years for the same purpose.

Grants awarded

The Cambridge European Trust made 81 awards under this scheme during 2004-05 at a total cost to the Newton Trust of $\pounds 162,000$.
