### **INTRODUCTION**

This report to the Council covers the period from 14 March 2006 up to, and including, the Trustees' meeting on 13 March 2007. It lists for the period new research grants approved by the Trustees and developments in the main schemes of the Trust. The audited Trust accounts for the year ended 31 January 2007 are given as Appendix 1.

A full account of the Trust's activities in earlier years may be found in Annual Reports volumes I to XVI. A summary of grants made by the Trust over the last 10 years (July 1997 to March 2007) is given in this report as Appendix 2.

The Council of Trinity College appointed Professor Sheilagh Ogilvie FBA and Professor Douglas Fearon FRS as Trustees for three years from 1 June 2006.

In addition, the Council reappointed Professor Nigel Weiss FRS as a Trustee from 22 November 2006 in the expectation that he would take over the Chairmanship of Trustees from Professor Wrigley in the summer of 2007.

Professor Hinch stood down as a Trustee since his subject area had become overrepresented among the Trustees. The Council of Trinity College accepted his resignation with effect from 30th September 2006.

Dr Fairbrother completed his period of service as Treasurer in September 2006. The Trustees express their thanks to both Professor Hinch and Dr Fairbrother for their periods of service to the Trust.

The Trustees appointed Dr C T Morley as Treasurer with effect from 1 October 2006.

The Trust maintains a website (www.newtontrust.cam.ac.uk) that gives up-to-date details of the Trust schemes. Those web pages that are concerned with the Cambridge Bursary Scheme (see page 17) are accessible to prospective applicants for undergraduate places from outside Cambridge. The remaining pages, including guidelines to applicants for grants, are accessible only from @cam addresses.

### AIMS AND OBJECTIVES OF THE TRUST

To promote education, learning and research in the University of Cambridge.

## FINANCIAL SUMMARY

#### **General Fund**

Trinity College has agreed to make donations to the Trust for the next five years of £2 million per annum. In March 2006 the College agreed to increase its payments in 2006-07 and 2007-08 to £2.5m pending a review of the Trust's activities to be carried out in 2007. These donations are credited to the Trust's General Fund. Grants from the General Fund are made to specific research projects and also to recurrent Trust schemes. A summary of the grants made from the General Fund from 1988 up to 13 March 2007 is shown in Table 1 and in graphical form in Figure 1. A breakdown of grants by Department made in the last ten years is shown in the Yellow Table in Appendix 2. A comprehensive list of earlier grants is shown in the Trust's Annual Reports Volumes XIV to XVI.

For some alumni the Trust has been found to be an attractive vehicle for donations as part of the University's 800th Anniversary Campaign. For this purpose the Trustees have established a (notional) 'Opportunities Fund'. Donations from alumni and others to this Fund and for bursaries totalling  $\pounds 153,000$  were received in 2006-07.

There was a significant increase in the value of the Trust's investments during 2006-07 largely as a result of improved market conditions.

After a low year in 2005-06, Trust expenditure on research grants returned to the normal level. There was a fall in expenditure on bursaries. This fall occurs largely for technical reasons having to do with the timing of bursary payments and will persist for three or four years until the new bursary scheme reaches its steady state.

The projections of future expenditure in Table 1 are speculative both as to amount and to timing. They include all the grants that the Trustees have approved, though experience suggests that some 20% of these grants will not, in the event, be taken up, either because circumstances change or else because the matching conditions have not been met.

Two projections of future expenditure are shown in Fig.1. Solid lines show the commitment projections of Table 1. Dotted lines show an extrapolation of present expenditure (averaged over the past 5 years including 4% inflation) to make allowance for possible future decisions of Trustees.

#### **Administration Costs**

Expenditure on Administration represents less than 3% of the Trust's turnover (including bursaries). A breakdown of Administration costs in 2006-07 is shown below.



### **RESEARCH AND TEACHING GRANTS APPROVED 2006-2007**

#### POLICY

The policy of the Trust in relation to Research and Teaching Grants is summarised in its Guidelines to Applicants. The key features of those Guidelines during 2006/2007 were as follows:

- The Trustees realise that the funds at their disposal could soon be wholly absorbed in a few big projects. They believe they can best assist the University by focusing their help selectively on projects of various sizes which otherwise might not get started or be significantly delayed, particularly those where a grant from the Trustees can open up opportunities for additional funds from outside Cambridge. The Trust is able to move quite quickly and so help in enabling opportunities to be seized which otherwise might permanently be lost. In all cases the Trustees need to be satisfied that projects are of a high standard. They aim to assist with the funds at their disposal a wide range of projects from Departments and Faculties in all Schools of the University.
- Since one of the purposes of the Trust is to attract resources from outside, grants from the Trust are normally conditional upon raising from sources outside Cambridge at least twice the amount of the grant. The Trustees have agreed to vary or even set aside this condition for projects that they consider of particular importance where the prospects of obtaining such external funding are remote.
- When applications are made to Research Councils in a routine way, the Trust will expect applicants to apply to the Councils for the full amount of the funds that they require. If a particular application is not wholly successful, the Trustees may be willing to consider an application for a top-up grant from the Newton Trust for a new initiative or project they regard as particularly important; and may allow the partial grant from the Research Council to be regarded as matching funds; but they do not guarantee to do so.
- The Trustees are persuaded that their most effective contribution is to help attract talented persons to Cambridge and to maintain the University's reputation as a centre of excellence in research. Thus the aim of the Additional Appointments Scheme (by which grants are made of up to £17,500 per annum for no more than 3 years, subject to matching amounts being raised from outside sources) is to provide limited-tenure research posts, perhaps involving a small amount of teaching, for academics early in their careers.
- The Trust does not normally contribute towards the costs of pre-doctoral students because PhD studentships are available from Research Councils, from the Cambridge Commonwealth, European, Overseas, and Gates Trusts, and from the Domestic Research Studentships competition organised by the Board of Graduate Studies.
- The Trustees do not in their own right seek funds from outside (the only exception being the Cambridge Bursary Scheme). It is therefore the responsibility of recipients of grants to raise the additional monies which are a condition of their grants from the Trust.

• The Trustees do not give priority to grants for equipment and in particular do not normally support requests for replacement of standard items. However, they have made modest provision for equipment grants and will give priority to requests for new equipment for teaching or new equipment which has multiple use. Such grants will normally be for no more than one-third of the total cost. The Trustees do not normally entertain requests for "bricks and mortar" projects.

### APPLICATIONS

In 2006-07 the Trust received a total of 71 new applications for support (a new record number; there were 46 applications in 2005-06). The total cost of supporting these applications in full would have been £4.1m. In the event, 57 applications were supported at a total cost of £2.8m (many grants being made at a lower level than had been requested). Fourteen applications were rejected.

In addition, the Trust invited applications from Departments in the Arts, Humanities and Social Sciences for matching support for post-docs seeking 2-year Early Career Fellowships from the Leverhulme Foundation. Some 36 applications were received and the Trust agreed to underwrite 16 of them in the expectation that no more than 10 would be successful in the Leverhulme competition. ### **GRANTS AWARDED**

The following grants (totalling £2.8 million) were approved by the Trustees during the report period. They are listed alphabetically by Department. The amounts of individual grants may be found in Appendix 2 (Yellow Table). If the matching requirement associated with each grant is achieved, the total matching sum associated with these grants will be £3.3 million. In some instances this matching sum would no doubt have come to Cambridge anyway; in others it has been elicited by the Newton Trust grant.

Applied Mathematics and Theoretical Physics: A grant over 18 months towards the salary of Dr João Rodrigues to work as a post-doc under the supervision of Professor Peter Wadhams on a project to quantify the current melt rate of Arctic sea ice and its variability over the past two decades, entitled 'Arctic sea ice thinning from submarine sonar data'.

Applied Mathematics and Theoretical Physics: A grant over two years towards the salary of Dr Pavel Berloff to work as a Senior Research Associate under the direction of Professor Peter Haynes on a project entitled, 'Dynamics and Mathematical Modelling of Mesoscale Oceanic Turbulence', in which the effects of turbulence on large-scale ocean circulation will be investigated.

*Applied Mathematics and Theoretical Physics:* A grant over one year towards the salary of Dr Nicolas Taberlet to work as a post-doctoral Research Associate under the supervision of Dr James McElwaine on a project entitled, 'Self-channelisation of laterally unconfined dense granular flows'.

*Archaeology:* A grant over nine months for the salary of Dr Diane Lister as a Research Associate to work on a project entitled, 'The potential for genetic analysis of historic barley landraces to trace the spread of cereal cultivation across Asia', together with a grant for consumables, and a grant for the travel expenses of Dr Lila Janik. (Applicant: Professor Martin Jones)

*Archaeology:* A grant over one year to support pilot fieldwork and post-excavation research to be undertaken by Dr Cameron Petrie on a project entitled, "'In the District of Pushkalavati" - exploring the geography and environment of Ancient Gandhara, and the archaeology of the Bala Hissar at Charsadda, North-West Frontier Province, Pakistan'. The investigation covers the period from the second millennium BC to the end of the first millennium AD.

*Biochemistry:* A grant over one year towards the salary of Dr Adrian Barbrook to work as a Research Associate under the direction of Professor Christopher Howe on a project entitled, 'Genetic markers for dinoflagellates', together with a grant towards essential consumables.

*Biochemistry:* A grant over two years towards the cost of consumables for use by Dr Susanne Gendreizig under the supervision of Dr Florian Hollfelder on a project entitled, 'Enzymology and selection of histone modifying enzymes'. Dr Gendreizig's salary will be met by an EU Marie Curie Fellowship.

*Biochemistry:* A grant over six months towards the salary costs of Dr Ellen Nisbet to work as a post-doctoral Research Associate under the direction of Professor Christopher Howe on a project entitled, 'Signalling from the chloroplast in the Malaria parasite *Plasmodium*', together with a contribution towards DNA micro experiments.

*Biochemistry:* A grant over one year towards the cost of consumables and small items of equipment for use by Dr K Nishikawa in the laboratory of Dr Martin Welch on a project entitled, 'Virulence factor production by *pseudomonas aeruginosa* biofilms'. Dr Nishikawa's salary will be met by the National Defense Medical College, Japan.

*Biotechnology:* A grant over two years towards the salary of Dr Maria Ruedas-Rama to work under the direction of Professor Elizabeth Hall as a post-doctoral researcher on a project entitled, 'I-DOTS : a methodology for real-time biochemical measurement in living cells'.

*Cambridge Colleges Libraries' Forum (CCLF):* A grant over five years towards the costs, including the salary of a part-time Manager, of a project entitled, 'ebooks@cambridge', which aims to establish robust, routine procedures for providing electronic versions of heavily-used textbooks and monographs to all resident members of the University. (Applicant: Dr Mark Nicholls, Librarian at St John's College, on behalf of the Project Management Team).

*Cambridge Institute for Medical Research:* A grant over ten months towards the salary of Ms Cathy MacLean to work under the supervision of Professor John Yates as a Study Coordinator (Research Associate) on a project entitled, 'Tuberous Sclerosis 2000 Study: Transition to Phase 2', which has the aim of improving treatment and outcome for children affected by the disease.

*Centre for Business Research:* A grant over two years towards the cost of a Senior Research Fellow to work under the direction of Professor Alan Hughes on a project entitled, 'Business and policy models for effective commercialisation of new technologies emerging from the science base', together with a grant towards travel costs.

*Centre for Family Research:* A grant to provide bridging support for up to one year for the salary of Dr Vasanti Jadva to work as a Research Associate under the Direction of Professor Susan Golombok on a project that seeks to investigate the quality of parenting and the psychological development of children in families created by assisted reproduction entitled, 'Families created by assisted reproduction: parenting and child development'.

*Centre for Research in the Arts, Social Sciences and Humanities (CRASSH):* A substantial grant over 5 years forming a second tranche of support for the Centre, both enabling the Centre's continuance at the current level of activity and providing resources for steady expansion. (Applicant: Professor Mary Jacobus, Director).

*Centre of International Studies:* A grant over one year towards an honorarium for Professor Richard Ned Lebow during his visit to Cambridge in 2007. (Applicant: Professor Christopher Hill, Head of Department).

*Chemistry:* A grant over 17 months towards the salary of a post-doctoral Research Associate to work under the direction of Dr Stephen Jenkins and Professor Sir David King on a project entitled, 'Atomistic modelling of catalysts for future energy technologies'.

*Chemistry:* A grant over three years towards the salary of Dr Li Liu as a post-doctoral Research Associate to work under the direction of Dr Oren Scherman on a project entitled, 'Cucurbituril: Towards stimuli-responsive functional materials'.

*Clinical Medicine:* A grant towards the purchase of an siRNA library with specificity for ubiquitin E3 ligases within the human genome for use by Dr Soma Sen Gupta under the supervision of Professor Paul Lehner.

*Clinical Neurosciences (Cambridge Centre for Brain Repair):* A grant over seven months towards the salary of Mr Jamie Marland to work as a Research Assistant under the supervision of Dr Philip Buttery on a project entitled, 'A molecular and cellular study of circuit homeostasis in mammalian brain', which seeks to contribute to the understanding of epilepsy and brain repair.

*Divinity:* A grant in the form of underwriting for up to two years towards the salary of Mrs Anne Fuller to work as editor under the supervision of Professor Eamon Duffy on a project to extract, transcribe, translate, calendar and prepare for publication the final volume (Vol XXII) of the *Calendar of Papal Registers relating to Great Britain and Ireland* to be published by the Irish Manuscripts Commission. The volume is entitled, 'The Vatican and Lateran Registers of Pope Hadrian VI (1522-1523)'.

*Earth Sciences (The Sedgwick Museum):* A grant over three years towards the salary and costs of a postdoctoral Research Fellow to work under the supervision of Dr David Norman on a project entitled, 'Charles Darwin's Geological Contributions (1831-1849): his body of work, its historical context and its originality', together with computer and software costs, and a contribution towards conference, publication, travel and subsistence costs. The project will form part of a major exhibition coinciding with Cambridge University's 800th Anniversary, the bicentennial of Darwin's birth and the sequicentennial of the *Origin of Species.* 

*Engineering:* A grant over two years towards the cost of scaling up a project entitled, 'Cambridge University Undergraduate Research Opportunities Programme (UROP)', a scheme to provide training for undergraduate students via vacation placements in a research group. (Applicant: Dr Hugh Shercliff)

*Engineering:* A grant over three years towards the salary of Dr Nalin Rupesinghe to work as a Research Associate under the direction of Dr Kenneth Teo on a project entitled, 'Nanoelectronics Production - Technology for Wafer Scale Carbon Nanotubes and Nanowires'.

*Experimental Psychology:* A grant over one year for the salary of Dr Meredith Shafto to work as a post-doctoral researcher under the supervision of Professor Lorraine Tyler on a project that seeks to determine how older adults preserve cognitive function in the face of extensive neural atrophy, entitled 'The neural correlates of successful ageing: improving word-finding in old age'.

*Genetics:* A grant in the form of underwriting for the salary of Dr Juan Mata to work as a Group Leader under the direction of Dr David Summers in the final year of a four-year project entitled, 'Role of RNA-binding proteins in cellular differentiation: a global approach'.

*Geography:* A grant in support of agency and other costs associated with the project entitled, 'Empowering workers in the New Economy: labour market intermediaries in the Call Centre Industry (comparing India and the UK)', which seeks to explore the work-home boundary, mobility patterns and worker empowerment strategies. (Applicant: Dr Bhaskar Vira).

*Gurdon Institute:* A grant over two years towards the cost of consumables for use by Dr Rick Livesey on a project that investigates the consequences of increased hormone levels on brain development, entitled 'Neocortical area formation and the pathogenesis of autistic spectrum disorders'. Dr Livesey's salary will be met by the US charity, Autism Speaks.

*Gurdon Institute:* A grant over one year as a contribution to the salary of Dr Francesca Cesari to work as a post-doctoral researcher under the supervision of Professor Azim Surani on a project entitled, 'Role of *EZH2* in germ cell lineage and pluripotency in mice'.

*Haematology:* A grant over one year for laboratory expenses to support the work of Dr Nicolas Bonadies as a post-doctoral researcher under the supervision of Dr Bernie Göttgens on a project entitled, 'Mechanisms of aberrant gene expression in leukaemia'. *History:* A grant over three years towards the salary of Dr Andrew Hann as a Project Manager , and towards the salary of Ms Gill Newton as a Data Manager under the supervision of Dr Leigh Shaw-Taylor on a project entitled, 'Historical European data on occupational structure and population', together with a grant towards the cost of workshops, computer equipment, travel and subsistence, and data digitisation. The project aims to facilitate multiple studies of long-term economic and social change across Europe.

*History:* A grant over one year towards the salary of Mr Calder Walton as a post-doctoral researcher under the direction of Professor Christoper Andrew on a project entitled, 'Intelligence History'.

*Materials Science and Metallurgy:* A grant over two years towards the salary of Mr Simon Hopkins as a post-doctoral Research Associate to work under the supervision of Dr Bartek Glowacki on a project entitled, 'Modelling and optimisation of magnesium diboride superconducting wires for MRI and NMR applications'.

*Materials Science and Metallurgy:* A grant over two years towards the salary of Dr David Cooke to work as a post-doctoral researcher under the supervision of Dr James Elliott on a project entitled, 'Structural modelling of the biological interface with materials', which aims to understand how biological systems can control the growth of minerals. (Applicant: Professor Lindsay Greer).

*McDonald Institute of Archaeological Research:* A grant over six months towards the salary of Dr Rhiannon Stevens to work with Dr Tamsin O'Connell on a project entitled, 'Reconstructing seasonal climate at archaeological sites via isotopic analysis of fauna: a case study in Upper Palaeolithic Moravia'.

*McDonald Institute for Archaeological Research:* A grant over one year towards research costs for Dr Alison Gascoigne to work on the Minaret of Jam Archaeological Project, undertaking scientific analysis of ceramics from the twelfth- to thirteenth-century site in Afghanistan.

*Oncology:* A grant over five months towards the salary of Ms Samantha Morris to work as a post-doctoral researcher under the supervision of Dr Shin-ichi Ohnuyma on a project entitled, 'Functional analysis of members of the small leucine-rich proteoglycan family in early embryogenesis, the advent of an extracellular network hypothesis'.

*Oriental Studies:* A grant over five years towards core funding of an archaeological project to take place in southern Turkey under the direction of Professor Nicholas Postgate entitled, 'Kilise Tepe'. The project has a particular emphasis on the Late Bronze and early Iron Ages.

*Pathology:* A grant over one year towards the salary of Dr David Ansell as a full-time post-doctoral Physicist to work under the supervision of Dr Chris Smith on a project entitled, 'The Naked Scientist', which broadcasts a weekly radio programme and internet podcast with the aim of encouraging young people to pursue a career in science.

*Philosophy:* A grant in part support of the salary costs of Dr Lubomira Radoilska to work on a project entitled, 'Drug distinctiveness and its impact on pharmaceutical ethics', under the direction of Dr Dominic Scott.

*Physiology, Development and Neuroscience:* A grant over two years towards the salary of Dr Miguel Luz Soares as a Research Associate to work under the supervision of Dr Anne Ferguson-Smith on a project entitled, 'Epigenetic control of gene activity and repression: regional influence of large repetitive domains in mammals'.

*Physiology, Development and Neuroscience:* A grant towards the salary of Dr David Welchman as a Research Associate under the supervision of Dr Benedicte Sanson for six months on a project entitled, 'Epithelial cell and tissue behaviours in the early *drosophila* embryo'. In addition, the Trust offered an interest-free loan towards the cost of a spinning disc confocal microscope.

*Physiology, Development and Neuroscience:* A grant over two years for the salary of a Research Assistant to work under the supervision of Dr Rob White on a project entitled, 'Genomics of gene regulation: towards understanding the regulatory genome'.

*Physiology, Development and Neuroscience:* A grant under the Trust's Conservation Biology Initiative over two years for the salary of a part-time technician to work with Dr Joan Tiffert under the supervision of Professor Bill Harris on a project entitled, 'The homeostasis of malaria-infected human red blood cells'.

*Plant Sciences:* A grant under the Trust's Conservation Biology Initiative over 15 months towards the salary of a postdoctoral researcher to work under the direction of Dr David Coomes on a project entitled, 'Meaningful measures of trends in forest fragmentation', together with a grant towards equipment and software.

*Plant Sciences:* A grant towards the purchase of a photon counting camera system for use by Dr Antony Dodd, Ms Fiona Robertson and Dr Guy-Bart Stan under the supervision of Dr Alex Webb on three separate BBSRC- and EPSRC- funded projects under the heading, 'The Circadian Signalling Network in Plants'.

*Psychiatry:* A grant over two years towards the salary of Mr Philip Corlett as a Research Associate under the supervision of Dr Paul Fletcher on a project entitled, 'Causal learning and Psychosis: developing a neurobiological model of delusion formation' in which neuroimaging is used to understand delusion in terms of brain function; together with a grant towards equipment.

*Social and Political Sciences:* A grant over 30 months towards the salary of Dr Peggy Watson to work under the direction of Professor John Thompson as principal researcher on a project entitled, 'Health care in post-communist Europe: Polish localities and meta-transformation'.

*Social and Political Sciences:* A grant over three years towards the salary of Dr Anneli Larsson to work under the direction of Professor Michael Lamb on a project entitled, 'Strategies for interviewing children who are reluctant to disclose sexual abuse'.

*University Library:* A grant over three years towards the salary of a Research Assistant to work under the supervision of Mr Peter Fox on a project which aims to make available the definitive print edition of letters to and from Charles Darwin by publication in *The Correspondence of Charles Darwin*, Cambridge University Press, 1984-, and via the website <a href="http://www.darwinproject.ac.uk/">http://www.darwinproject.ac.uk/</a>>.

*Veterinary Medicine:* A grant towards research expenses in connection with the project entitled, 'Efflux transporters in the equine placenta' to be undertaken by Dr Clare Bryant and Dr Arno Werners.

*Zoology:* A grant over three months for the salary of Dr Claire Jackson to work as a postdoctoral Research Associate under the direction of Dr Brian McCabe and Professor Sir Gabriel Horn on a project entitled, 'Gene expression in a memory system in the brain of the domestic chick'.

*Zoology:* A grant over nine months towards the salary and costs of Dr Camilla Hinde to work as a Research Associate under the supervision of Dr Rebecca Kilner on a project entitled, 'Maternal effects and parent-offspring conflict'; a grant over two years as matching funding for a Leverhulme Early Career Felllowship for Dr Hinde.

*Zoology:* A grant over 2.5 years towards the salary costs of Dr Salomé Antolin to work with Dr Gregory Jefferis on a project entitled, 'The neural basis of olfactory perception in the fruitfly', together with a grant towards the purchase of a stereomicroscope.

*Zoology:* A grant under the Trust's Conservation Biology Initiative over one year towards the salary of Dr Jorn Scharlemann to work under the supervision of Dr Andrew Balmford on a project entitled, 'Agricultural commodities and tropical conservation', together with a grant towards equipment and software costs.

*Zoology:* A grant under the Trust's Conservation Biology Initiative over one year towards the salary of a Research Associate to work under the supervision of Dr Andrea Manica on a project entitled, 'The sustainable use of species and ecosystems', together with a grant towards equipment costs.

## **RECURRENT TRUST SCHEMES**

#### THE CAMBRIDGE BURSARY SCHEME

#### Aims and objectives

The scheme of Newton Trust Bursaries for UK Undergraduates was set up in 1990 in response to the progressive phasing out of student grants, the introduction of student loans and later of tuition fees. The main purpose of the scheme is to help attract the best candidates to Cambridge and to widen the field from which they are drawn, through support for students from disadvantaged backgrounds and from families with modest financial resources.

The Trust is presently running two versions of the scheme in parallel as described below.

#### **Financial summary**

The Trust has received three Special Donations from Trinity College towards the endowment of the Bursary scheme. These donations have been credited to the Bursaries Endowment Fund shown in Table 2(b). The Fund showed a significant increase in 2006-07, largely owing to improved market conditions. In addition the scheme has been supported on a recurrent basis by several sponsors. Several new sponsors were recruited in 2006-07. The Trustees are also grateful for a number of contributions to the scheme from Cambridge alumni (both from Trinity and other Colleges) made as part of the 800th Anniversary campaign. From 2006 onwards a significant part of the cost of bursaries for the New Scheme (see below) is being met by the University as a contribution from top-up fees. This 'top-up fee contribution' is accounted for separately in Table 2(c). The remaining costs of the scheme are met by a transfer from the General Fund as shown in Table 2(a).

#### **Policy (Old System)**

The Trustees agreed in 1999 to offer a guarantee that any student in receipt of full LEA fee remission (i.e. with a parental income of less than about £20,000) would receive a full bursary of £1,000, with a sliding scale for students who qualify on the basis of their parental income for a lower level of fee remission.

The cost of these awards is borne in part by Colleges, broadly in line with their endowment income per capita. Levels of contribution are shown in Table 3. Gonville and Caius, St John's, and Trinity Colleges pay the cost of awards for their own students.

A long-term evaluation of the bursary scheme, funded over ten years by Atlantic Philanthropies, is being carried out by the University's School of Education.

The scheme of bursaries is advertised on the Trust's web-site, in the University prospectus and in advertising sent to schools. This material includes a guarantee that any student who qualifies for full fee remission will also be awarded a full bursary.

The Trustees and Colleges have agreed to maintain the old system bursary scheme substantially unchanged for every student presently in residence. It will progressively wither on the vine as new generations of students are admitted under the new system of tuition fees from 2006.

#### **Policy (New System)**

Under the Higher Education Act passed in 2004, Universities are permitted to charge socalled top-up fees on condition that they have a bursary scheme in place which guarantees minimum bursaries to UK students from the poorest families. These arrangements are policed by a regulator, the Office for Fair Access (OFFA). Cambridge charged the maximum top-up fee permitted from 2006, and the University and Colleges asked the Trust to administer an expanded bursary scheme in fulfilment of the OFFA requirement. This involves a substantial increase in bursary amounts, well in excess of the minimum required, and also a widening of the categories of student who receive bursaries. The cost of the bursary scheme increased substantially in 2006 and will continue to rise as successive cohorts of students fall under the new fee arrangements, increasing to a steady state of about £6 million per annum by 2011.

Fundraising for bursaries is a major part of the University's 800th Anniversary Campaign. Several Colleges are using student support as a major plank in their fundraising, some with notable success. With the agreement of all parties involved, an arrangement has been worked out whereby Colleges that are particularly successful in their fundraising for bursaries can meet a higher-than-normal share of the cost and they will then be reimbursed by the Trust. These are the 'Bursary Compensation Payments' shown in Table 2(a).

#### Results of the 2006-07 Bursary allocation (Old Scheme)

All eligible applicants were awarded a bursary on a sliding scale up to  $\pm 1,000$  thereby meeting the Trust's guarantee. The number of awards made is given below:

- a total of **1150** bursaries were awarded at a total cost of about **£866,000**;
- the cost to the Trust net of College contributions is about **£713,000**;
- of the total **1175** applications for bursaries (new and renewals), **25** were deemed ineligible to receive support;
- 91 of these awards remain to be settled upon receipt by the Trust of students' LEA assessments.

Numbers and costs of awards by College are shown in Table 3. The average value of each Old Scheme bursary awarded in 2006 is  $\pm$ 750.

#### Results of the 2006-07 Bursary allocation (New Scheme)

All eligible applicants were awarded a bursary on a sliding scale up to £3,000 as specified in Cambridge's OFFA agreement. Some 22 students met the criteria (being over 21 when they started their undergraduate course and resident in Cambridge throughout the year) for a higher tier bursary of up to £5,000. The number of awards made is given below:

- a total of **598** bursaries were awarded at a total cost of about £1.27m;
- the cost net of College contributions is about **£1.14m**;

- of the total **636** applications for bursaries, **38** were deemed ineligible to receive support;
- **86** of these awards remain to be settled upon receipt by the Trust of students' LEA assessments.

First year students (only) taking the Graduate Course in Medicine were invited to apply for a bursary. Seventeen students applied; 13 bursaries were awarded; 4 remain to be settled.

New Scheme awards were paid in two instalments (at Christmas and Easter).

Numbers and costs of awards by College are shown in Table 4.

Some 9 Colleges, (Corpus Christi, Jesus, Magdalene, Girton, Clare, Queens', Churchill, St Catherine's and Sidney Sussex) took advantage of the new Bursary Compensation Payment arrangement by meeting more than the required cost of their bursaries with contributions from their alumni. Bursary Compensation Payments totalling £120,000 will be made in due course.

Several new commercial sponsors of the Bursary Scheme were recruited, in particular by CUDO. Amounts are shown in the Bursaries Table.

Of New Scheme bursaries awarded, about 40% were at the maximum level and 60% at some point on the taper.

#### Collaborators

*Atlantic Philanthropies* continue to fund the evaluation of the Bursary Scheme carried out by the University's School of Education.

Armourers and Brasiers: Four recipients of Armourers and Brasiers awards were identified and the recipients notified. A cheque for £2,000 was received from the Company.

Cambridge Society: The seventh Cambridge Society bursary was awarded.

*Carpenters:* The Carpenters Company agreed to support a bursary for a student reading Architecture. The first Carpenters Company bursary has been awarded.

*Caterpillar:* The Caterpillar Foundation agreed to support four bursaries for students reading Engineering. Four first-year students of Mechanical Engineering were identified as the first recipients of the new Caterpillar Newton Trust awards.

*Clifford Chance*: Clifford Chance continue to make a contribution to the bursary scheme at a level of £35,000 per annum and these figures have been included in the projections. A reception for Clifford Chance bursars was held on 6 March 2007 at Trinity College.

Lovells Fourteen bursaries ongoing from 2005-06 were awarded to second-year Law students.

*Man Group:* The Man Group plc agreed to support seven bursaries for students taking courses in Mathematical disciplines. Five first-year students of Mathematics and two first-year students of Economics were identified as the first recipients of the new Man bursaries.

*Thermo Fisher Scientific* (previously Thermo Electron) have agreed to sponsor two bursaries of  $\pounds 6,000$  over four years ( $\pounds 1,500$  per year) to Natural Sciences students. A cheque for  $\pounds 9,000$  for the third year has been received from the Company and a further two bursaries were awarded.

*Dharam Hinduja Newton Bursarie and Malaysian Commonwealth Studies Bursaries* were awarded as usual. Contributions from the sponsors, £15,000 and £20,000 respectively, were received.

#### **Grants for Community-Related Projects**

The Trust has continued to operate a scheme offering contributions to community-related undergraduate projects with preference being given to bursary-holders and those undertaking projects within the UK. Some 106 awards were made under this scheme in 2006-07 at a total cost of £22,950. Most of the grants to individuals were for sums less than £500, but within the total the Trust approved a grants of £2,000 to Student Community Action and £800 to the Humanitarian Centre towards equipment and office costs.

#### **RESEARCH STUDENT FUNDING**

The Trust supports Research Students at Cambridge in three ways: through a now vestigial scheme of Awards for UK Research Students in the Arts, Humanities and Social Sciences described below; through the Board of Graduate Studies Scheme of Domestic Research Studentships (available to both UK and EU students) described on page 29; and through the scheme of Newton European Research Studentships (for EU students) operated by the Cambridge European Trust and described on page 29.

#### Newton Awards for UK Research Students in the Arts, Humanities And Social Sciences

A new and experimental scheme of awards restricted to the Arts, Humanities and Social Sciences operated for the first time in 2002. Awards of £1,500 per year were offered for new PhD students from the UK holding either a 3-year Research Council maintenance grant or a similar 1-year Research Council grant with the intention of proceeding thereafter to the PhD degree in Cambridge. The scheme operated for the second time in 2003. A review by the Trust in 2004 decided that the scheme should be discontinued (details are contained in Annual Report Volume XIV pp.20-21).

No new awards were made under this scheme in 2006-07, but one award is ongoing from those who started in 2002 and six awards are ongoing from those who started in 2003. Total cost of these awards in 2006-07 was  $\pounds 10,500$ .

#### **COLLEGE TEACHING OFFICER (CTO) SCHEME**

#### Aims and objectives

The aims of this scheme is to increase CTO involvement in Faculty teaching and the amount of University teaching available, allow Faculties to choose such extra teachers from CTO ranks as they wish, make it possible for the Tuition Funds of poorer Colleges to afford the consequent reduction in the amount of CTO teaching, to provide a career training opportunity, and to achieve these aims through a scheme that is simple to operate.

Tenure in these posts was initially limited to a maximum of ten years. In a review of the scheme in 2004 the maximum tenure was reduced to 8 years so as to offer greater opportunity to CTOs appointed by Colleges for short periods to compete for a post.

The original scheme established in 1992 operates across faculties, though in practice most posts are in the Humanities.

#### Summary of awards 2006-2007

**Twenty-eight** posts are currently filled. One post-holder is on leave: Dr Henry. There are **six** vacancies. A list of present holders of awards is given in Table 4 below.

#### Costs

The cost of the CTO scheme for the academic year 2006-2007 was £97,445

#### **Recent changes**

Several new appointments, reappointments and resignations arose during the year:

#### **Faculty of Economics**

<u>Dr Demosthenes Tambakis</u> (Pembroke College) was appointed for five years from 1 October 2006.

#### **Faculty of English**

<u>Dr Sarah Brown</u> (Lucy Cavendish College) resigned her post with effect from 30 June 2006 to take up a Chair at Anglia Ruskin University.

Dr Katrin Ettenhuber (Pembroke College) was appointed for 5 years from 1 October 2007.

<u>Dr Hester Lees-Jeffries</u> (St Catharine's College) was appointed for 1 year from 1 October 2006 as a temporary replacement for Dr Anne Henry, who is on leave.

Dr Leo Mellor (New Hall) was appointed for 5 years from 1 October 2006.

<u>Dr Subha Mukherji</u> (Fitzwilliam) resigned with effect from 1 January 2007 to take up a Lectureship at the Faculty of English.

<u>Dr Daniel Wakelin</u> (Christ's College) resigned with effect from 30 September 2006 to take up a University Lectureship.

#### TIME-LIMITED TEACHING FELLOWSHIPS SCHEME

#### Aims and objectives

The aims and objectives of this scheme are to strengthen the undergraduate supervision system at the less well-endowed Colleges, thereby helping to produce a more even playing field between well-endowed and less well-endowed Colleges; and to help to integrate some of the holders of Newton Additional Appointments and similarly placed postdoctoral researchers into College life.

#### Policy

The Trustees agreed in 1999 to make up to 25 grants available to enable young postdoctoral researchers to be elected to teaching Fellowships at the less well-endowed Colleges shown below. Each appointment may be held for up to 5 years. The duties of each person appointed include giving 4 hours per week of undergraduate supervision. In return the Trust pays the College £4,000 per annum towards the overheads involved. In 2004 the Trustees agreed to increase the maximum number of posts available under the scheme from 25 to 30 from 2005 onwards.

#### **Appointments made**

## **GRANTS MADE TO OTHER BODIES**

#### DOMESTIC RESEARCH STUDENTSHIPS

#### Aims and objectives

To award research scholarships to the best 'Home' (i.e. UK and EU) students who fail to gain support from public sources such as the Research Councils and the AHRC.

#### Policy

The Newton Trust agreed in 1997 to contribute £75,000 per annum for five years to a University-wide scheme, adding to other sources of funds to increase the number of awards available. The awards are made by the Board of Graduate Studies on the advice of Academic Division's Committee on Awards. The majority of awards are made to students in the Arts and Humanities. During 2002-03 the Trustees agreed to extend the period of support for a further five years at £85,000 per annum; in 2004 agreed an increase to £90,000 per annum.

In addition, the Trust agreed in 2002 to provide underwriting of £250,000 over a five-year period to enable firm offers of support to be made earlier by the Committee on Awards to strong candidates who might otherwise be tempted to go to other Universities but who were likely in the event to receive funding from public sources.

#### **Grants awarded**

In 2006 some 17 new awards were made. The Secretary of the Board of Graduate Studies reported that the availability of the Trust's underwriting had been useful in enabling early offers of awards to be made to students who might otherwise have moved elsewhere but who had, in the course of events, subsequently been awarded a studentship by AHRC. £188,681 of the underwriting remains available.

#### NEWTON EUROPEAN RESEARCH BURSARIES

#### Aims and objectives

The aims and objectives of this scheme are to encourage able students from the European Union to do research at Cambridge and to help them take up their places. (EU students are eligible for support from public sources for their fees, but not for maintenance.)

#### Policy

The Trustees agreed in 1999 to make a donation to the Cambridge European Trust totalling  $\pounds 600,000$  to provide a pilot scheme of Newton European (Research) Studentships of annual value up to  $\pounds 2,000$  tenable for up to three years, to be awarded to PhD students from the EU by the Cambridge European Trust on the basis of departmental recommendations. A further  $\pounds 400,000$  was awarded during 2002-03, and in 2004-05 the Trustees agreed to make a further and final grant of  $\pounds 400,000$  over two years for the same purpose.

#### Grants awarded

The Cambridge European Trust reported that 86 awards had been made under this scheme during 2006-07 at a total cost to the Newton Trust of  $\pm 172,000$ .
